WHEREAS the Board of Directors of the Credit Union has recommended that the Credit Union amalgamate with both Noventis Credit Union Limited ("Noventis") and Sunova Credit Union Limited ("Sunova") in accordance with the provisions of the Amalgamation Agreement made between the Credit Union and Noventis and Sunova, dated December 15, 2021 (the "Amalgamation Agreement");

AND WHEREAS it is in the Credit Union's best interests to enter into the Amalgamation Agreement and to amalgamate with Noventis and Sunova on the conditions set out therein;

NOW THEREFORE BE IT RESOLVED AS A SPECIAL RESOLUTION OF THE CREDIT UNION THAT:

- 1. The execution of the Amalgamation Agreement by the Credit Union be and it is hereby ratified and confirmed;
- 2. The amalgamation of the Credit Union with Noventis and Sunova on the terms and conditions set out in the Amalgamation Agreement be and it is hereby approved.
